THE GENTRY FAMILY

The earliest known ancestors of our Gentry line were James Gentry, born in Kentucky and Susanna, his wife, born in Tennessee. The date of their marriage was prior to 1832 since the date of birth of their first child of record was about 1832. The place of their marriage is not known. It could have been in Kentucky, Tennessee or possibly somewhere in Indiana since, according to the 1850 census, their first six children were born in that state. By 1846 the family was living in Missouri. The 1850 census shows them living in the Bonhomme Township, St. Louis County, Missouri in the household of Michael Clark. There were nine children in the family at this time. Many families migrating into Missouri stopped in St. Louis County to grow and harvest crops from the rich Bonhomme "bottoms" before proceeding on to new lands.

Their seventh child, Andrew, was born in Missouri, possibly in St. Louis County but the census of 1860 shows the family living in Macon County, Missouri. Then, sometime between 1860 and 1865, the family moved to Wayne County, Missouri. Susanna died there in February of 1865. They must have lived in the eastern part of Wayne County because she is buried just over the county line in Bollinger County in the Kinder Cemetery.

The 1870 census shows James Gentry, Widower, living in the household of his son, James Lewis Gentry. in Wayne County, Missouri.

- (3) William M. Gentry, James and Susanna's first child is believed to have married a Liddy Ann Metcalf 21 July 1853 in Macon County, Missouri and may have spelled his name Jentry. However, nothing is actually known about him after the 1850 census record.
- (4) Martin S. Gentry married Maegart (or Margaret) M. Gafton 14 April 1859 in Macon County, Missouri. He is found in the 1860 Census of that county with his wife Margaret and daughter, Nancy E. (one month old) and living two families away from James and Susanna Gentry. Nothing more is known of this family.
- (5) Rebecca Ann Gentry, it is believed, married William R. Brock 5 September 1858. The 1860 census of Macon County, Missouri lists this family as living next to James and Susanna Gentry on one side and Martin and Margaret Gentry on the other side. However, there are two children listed in this family who must have been children of a previous marriage since their ages were seven and five years old too old to have been born of this marriage if the marriage date of 1858 is correct and assuming that the Rebecca Gentry who married William R. Brock is the daughter of James and Susannah Gentry. Rebecca's age in this record coincides with the age of James and Susanna's daughter, Rebecca, and her birth place is given as Indiana and the fact that she and William were living in close proximity to James and Susannah and to Marten and Margaret Gentry makes the assumption reasonable. The children's names were John G. (age 7) and Susan G. (age 5), both born in Missouri.

(7) James Lewis Gentry, (our ancestor) fourth son and fifth child of James and Susanna Gentry, was born in September of 1840 somewhere in Indiana.

James Lewis Gentry and a brother (supposedly his older brother, William M. Gentry) fought in the Civil War on opposite sides. James Lewis for the Confederacy and William for the Union. James Lewis always said that had he not been working in the South at the outbreak of the War, he would not have fought for the Confederacy for he was opposed to slavery. Although he was glad the North had won, he felt strongly that the North was much to blame for the war and that the issue could have been settled peaceably. He was enlisted 3 September 1862 at Camp Mitchell, Arkansas by Col. McClarty and served as a Private in Co. A, 10th Mo. Inf., CSA. His record shows that he went on sick furlough from 12 April 1863 to 12 May 1863. He was a Prisoner of

. . . .

War from the time Col. Moore surrendered his command at New Orleans, Louisiana on 26 May 1865. His was the last Company to surrender. James Lewis was paroled at Camp Allen, Shreveport, Louisiana on 8 June 1865.

The story goes that the two brothers somehow met after the peace and went home together. There have been many stories told over and over again about some of the incidents that happened on the trip home but those must be saved for another chapter. When the two brothers reached home they were exhausted and weak from starvation and when two sisters came running across the field to welcome them home they had to back themselves into a corner of the rail fence to keep from being bowled over.

My father described James Lewis as a tall man, 6, and rawboned, with sandy red hair, a reddish complexion and freckle-faced. He was a forthright and honest person, a religious man and did very little swearing. He was always cheerful and had a good sense of humor. Politically, he was a Democrat, as were all the Gentrys.

James Lewis Gentry married (8) Harriet L. Morgan, daughter of William Morgan and (I believe) Delpha (?) Pearce. There is very little known about Harriet The birth date of 5 September 1847 was found on her tombstone in the McFadden cemetery. Dover, Pope County, Arkansas and family members informed me she was born in Sharp County, Arkansas (formed from Lawrence County). The 1850 census of Lawrence County lists a Harriet (age 3) in the household of a William and -Iveny (Delphiny?) Morgan but ten years later in the 1860 census of the same county the only Harriet Morgan (age 13) was listed in the household of Rodney Armstrong. In the 1850 census the third child in William Morgan's household was named Rodney. In checking the marriage records of Lawrence County there was found a marriage between a William M. Morgan (age 20) and Sarah King (age 17) on 15 March 1843 and also a marriage between a William Morgan (age 44) and Delpha Pearce (age 17? or 19?) on 11 June 1845. In the household of William and --Iveny Morgan in the 1850 census there were three older children listed; --mly (Emily?) (age 16), John (age 12) and Rodney (age 11) then three more children; Harriet (age 3), Alford (age 2) and Morgan (age 3 months). The gap of several years between the birth of Rodney and the birth of Harriet indicates a first and a second marriage. There were evidently at least two more children born to this second marriage for in the 1870 census of Wayne County. Missouri there is listed in the James L. and Harriet Gentry household a Jesse Morgan (age 16), brother-in-law to James L. and a Sarah C. Morgan (age 14), sister-in-law to James L. (Sarah Catherine either came to Pope County, Arkansas when James Lewis moved his family there, or, she married in Missouri and moved with her husband. James R. Burcham, to Pope County for she lived many years in Dover. This information came from a telephone conversation with Sara Catherine's granddaughter. Sarah Catherine was known by her family and friends as "Kate".)

In the 1900 census of Pope County, Arkansas Harriet was listed as the Mother of 12 children with 11 living. But, no document or verbal record has been found for the death of any of their children prior to 1900. As far as can be determined, they all lived to see the 20th century.

(14) Alfred D. Gentry is found in the 1880 census of Wayne County, Missouri living in the household of James Lewis and Harriet Gentry. That census record also indicates that he had been unemployed for 12 months. Nothing further is known of this person and no research has been undertaken.

2ND GENERATION

(15)William M. Gentry, first son of James Lewis Gentry and Harriet L. Morgan was born in Missouri. Very little is known of this person. A nephew recalls that about 1918 or 1919 he obtained a job managing "...an old plantation..." at Wilmot, Ashley County, Arkansas and moved there with his father and "...three or four brothers..." and their families. It is not known how long they all stayed there nor where William went after leaving there. The same nephew recalls that an entire railroad freight car was rented to move all of their belongings when they left there.

(16)Frances Elizabeth Gentry, always known as "Lizzie", was born 23 December, 1869 in Missouri, probably in Wayne County. She married Alexander Hardcastle 12 February 1885 in Pope County, Arkansas and lived all her life in that county in or near the town of Russellville.

Mrs. Chloe (Benefield) Brown (interviewed in 1993) was a neighbor to the Alex Hardcastle family on Three Knob Mountain, for 40 years and described "Lizzie" as a short, stout woman with black hair. She could sew well and was always dressed neatly and becomingly. She and her daughter, Maude, were the only ones in that family with black hair (all the rest were red-headed) which could have been a legacy from "Lizzie's" mother, Harriet L. Morgan who, I suspect, was of Welsh descent.

She helped take care of her sister, "Rate" (who lived nearby) during her last illness and the sickly baby left by her sister's death in May of 1909. However, the baby, Jules, died a month later. Her sister, "Rate", left four other children, all young and needing care. There arose a bitter dispute between their father, John Kelley, and Alex Hardcastle as to the placement of these children. The rift between the two families was never mended.

Frances Elizabeth (Gentry) Hardcastle died in 1953, 16 years after the death of her husband and is buried in the Pollard (now White Church) Cemetery near Dover, Pope County, Arkansas.

(17)Henry Clay Gentry, third of the twelve children of James Lewis Gentry and Harriet L. Morgan, was named for the famous orator and statesman. James Lewis and Harriet Gentry seemed to have a penchant for naming their children after famous political or military figures. Henry was born 25 April 1871 in Missouri, probably in Wayne County. In his older years he was a stout man with a florid complection and not very tall.

He is found in the 1880 census of Wayne County, Missouri with his parents and siblings and in the 1910 census of Pope County, Arkansas with Janie, his wife, and seven children. Where he was for the 1900 Census is unknown but he could have been and probably was, in Pope County, Arkansas for he was married there to his first wife in 1893. The marriage to his second wife is also recorded in Pope County, Arkansas in 1899. He married a third time in 1952, at the age of 80, in Tulsa County, Oklahoma.

During the 1930's, then living in Sand Springs, Tulsa County, Oklahoma he supposedly had in his possession a small mirror, approximately 6" x 8" with a black frame which was alleged to have been given to a Gentry ancestor by George Washington.

(18) Sarah Josephine Gentry, (aka "Phine") second daughter of James Lewis and Harriet L. (Morgan) Gentry was born at years end of 1873, most probably in Wayne County, Missouri. She appears first in the 1880 census of that County as being six years old with her parents and six siblings. Twenty years later in the 1900 census of Pope County, Arkansas she is still, or again, in the household of her parents, as the widow of William A. Hardcastle with two children, ages nine and six. By 1910 she has remarried (to John "Jack" B. Lay, a man much older than she) and has two more children, ages six and five.

She continued to live in Pope County, Arkansas until her death of Typhus in the little town of London in July of 1924.

(19)Mary Alva Gentry (our ancestor) was the fifth child, third daughter of James Lewis and Harriet L. (Morgan) Gentry. There has been much confusion around her name. Her son, Clarence Adell Kelley, told me her name was Rachel. A nephew, Raymond Gentry also told me her name was Rachel. But, to family and friends, and evidently to the entire community, she was always called "Rate". On census records she is listed as Mary and Mary A. Her daughter, Lucy Myrtle (Kelley) Waits, informed me that her second christian name was Alva. On her marriage license she is signed Miss R. A. Gentry. On her son Clarence's birth certification her name is given as Rettie A. The information for this birth certification was given by her brother George Gentry. In any case, the name Rachel has not appeared or any document found to date. I have come to refer to her as Mary Alva Rettie (Gentry) Kelley.

Mary Alva Rettie, according to a family story, fell in love with a young man of whom her parents highly disapproved and they somehow prevented the marriage. When she accepted the proposal of John Kelley they again voiced their strong objections on the grounds that he was much older than she and not always in good health. He had already lost one eye so he was partially blind and he was of a harsh disposition. She evidently defied them for the marriage took place in October of 1894.

The 1900 census of Pope County, Arkansas shows that in the six years of her marriage she gave birth to four children with only two of them surviving. The first child, a daughter, lived only a few hours and was named Ardelle. The third child was also a daughter but did not live long enough to be named. The two surviving children were a daughter, Ida Belle, and a son, James William. She subsequently gave birth to three more children before her death in May of 1909 of Tuberculosis. The last child, a son named Jules (Julius) born about August of 1908, survived his mother by less than a month. Ill when his mother died he was left to the care of his two sisters, Ida Belle and Lucy Myrtle, and his Aunt "Lizzie" Hardcastle but succumbed to what was termed "Summer Complaint" in June of 1909.

(21)Emma (or Emily?) A. (or H.?) Gentry, James L. and Harriet Gentry's seventh child, always known as "Em" was born in Missouri, probably in Wayne County, in the early part of 1879. Her pictures, while she was still raising her family, show a rather angular, long face, hair dark (could have been red) parted in the middle with a bun on top and to the back. Her mouth straight and thin lipped and a long straight nose.

She appears in the 1880 census of Wayne County, Missouri as (Emily H.

Gentry) with her parents and siblings but by the 1900 Census of Pope County, Arkansas she is Mrs. George Loyd, newly married. She and her family also appear in the 1910 and 1920 censuses of Pope County, Arkansas. Sometime after 1920 this family moved to Oklahoma but not to Sand Springs, Tulsa County as did so many other members of the Gentry families. Their new location is not known but, possibly, the little town of Oolaga in Rogers County, Oklahoma.

(23) Charles Alvie Gentry, eighth child and sixth son of James Lewis and Harriet L. (Morgan) Gentry, was born in Arkansas, probably in Pope County, in the fall of 1886. Knowledge of this family is sketchy. He married Ada Frances Ross on Christmas Day in 1904. Both of them were very young. He was parely 18. She was not yet 16.

This family was living in Sand Springs, Tulsa County, Oklahoma in the 1930's along with several other Gentry families and at least one other Ross family. They, with other Gentry relatives, later moved to California, probably in the early 1940's to work in the war time defense plants. They were living in Orange County at the time of their deaths. His is 1968 and hers much earlier in 1956.

(24)George Washington Gentry, tenth child in this family was born in Arkansas, most likely in Pope County in the spring of 1883. This man loved children and was a great favorite with the various nieces and nephews. He always picked them up and made a big fuss over them. He smoked and always had a sack of Bull Durham tobacco in his pocket with the tag on the end of the draw string hanging out. The children used to love to grab the tag, and yank the sack of tobacco out of his pocket as he swung them up in the air.

He, like his brother Charley, was fair complected with rather heavy facial features and to the children they were tall, broad shouldered men. He was always cheerful with a good sense of humor. Politically he was a staunch Democrat as were all the Gentrys.

George W. Gentry was married twice. He married first Emma Mae Chilton in 1902. There were three children born of this marriage. After the death of Emma Mae in May of 1909, (George's sister, Rate (Gentry) Ke ley, also died in May) he and his three children lived for a time in the household of his brother Tom. He married again in 1911 to Mary Ella Williamson, daughter of James W. and Elva (Barber) Williamson. Her sister, Emma Jane ("Janie") was married to George's older brother, Henry Clay Gentry. To this marriage was born eight children. The first child of this second family was stillborn and very nearly took the life of it's mother. The subsequent seven children were all born healthy and strong with one exception. Their third child, Thayer, although healthy, was born with a deformed hand.

After coming to Sand Springs, Oklahoma, (sometime between 1913 and 1915) he ran a grist mill on his property for some time but when his health began to fail and the Doctor told him breathing the dust generated by the mill would kill him within the year, he shut the mill down and moved into the little town of Sand Springs and hired himself out as a grave digger at the cemetery. He would dig a grave for \$5.00 for anyone who wished to hire him. The families of the deceased could come in and dig the graves but he was on the premises for hire if they wished. I believe he was given a house on the cemetery grounds. His good health returned and he lived on for more than 30 years.

This family also came to Southern California sometime after World War II was declared and some of the family went to work in the defense plants in the Los Angeles area. George W. Gentry died in 1962 in Bell, Los Angeles County, California and Mary Ella ("Eller") lived on until 1969.

(25)Kosciuszko B. Gentry, named for the famous Polish General of the Revolutionary War, later shortened his name to Oscar but was always called Osco. It was not until a visit with one of his nephews that it was revealed that Oscar was not the name given him at birth.

This writer has almost no other information about this eleventh child of James Lewis and Harriet (Morgan) Gentry. He was born in August of 1888 in Arkansas, probably Pope County, married and had a least one child, a daughter, named Eva. There were probably other children.

(26)Labanal ("Banal") A. Gentry was the last child born to James Lewis and Harriet (Morgan) Gentry. He and his father, James Lewis, were living in the household of his older brother, Charles Gentry, in the 1910 census of Pope County, Arkansas. The 1920 census of Tulsa County, Oklahoma in the Sand Springs Grant township, he is the head of his own household. He was still in Sand Springs in 1922 for he appears in a directory of Tulsa County. When he left Sand Springs or where he later resided is not known.

3RD GENERATION

Since so little is known of the people of this generation, this section will deal mainly with the descendants of Mary Alva Rettie (cr "Rate" or Rachel) Gentry and John Hankins (or Henry) Kelley.

(19a)JOHN HANKINS KELLEY

Not a great deal is known about John Kelley. On the birth certifications of his daughter, Ida Belle and his son, Clarence Adell, his name is given as John Hankins Kelley but a grandson, when speaking of him, refers to him as "...old John Henry...". It is unlikely that we will ever know which is correct. He was, from all accounts, of a harsh, mean disposition, feared by most in the community for he always carried in his pocket a knife with a 4 inch switch blade. It was said that when he pulled this knife from his pocket, the blade was always out and ready for use. He was also a very bitter man, toward life in general and specifically toward the northern states and the outcome of the Civil War. He never spoke of his childhood and never, to anyone's knowledge, spoke of his parents or what happened to the family either during or after the Civil War except to make it known that they had lost everything because of the war. He was almost 40 before he married and I think in bad health at the time. He had already lost one eye by an infection, or neuralgia. One story goes that the eye was so painful (cause unknown) that he himself tore it out! A photograph of him shows a gaunt, thin faced man, bearded and with a drooping mustache. The one eye sunken, the lost eye hidden by its closed eyelid as if in a permanent wink. The nose is long and sharp.

He worked himself and his family hard. One of his brothers-in-law said that he had worked his wife to death and a son used to re ate a story about how he acquired what little education he had. During the winter, the first thing he did in the early morning was to go outside and kick at the ground. If it was too frozen to be worked, then he knew he would be permitted to go to school that day. In spite of his harsh nature he commanded respect from the people who knew him for he was an honest man and a proud man, never accepting anything he couldn't earn or pay for.

John Kelley was born, somewhere in Alabama supposedly, on 9 November 1855. He was only six years old when the Civil War began and his older brother. James Daniel, was only seven or eight years old. There was a daughter born in 1864 and it is said her birth occurred after the death of the father. Did the mother die in childbirth? Were there other siblings? If so, what happened to them? How and where did the father die? The family legend tells us the children were brought to Arkansas by an "Uncle Sandy Reed". Was this man blood kin? perhaps a brother to the children's mother? The first appearance of these children is found in the 1870 census of Pope County, Arkansas with James and John listed in the household of a John, William and Margaret Rankin family. Where was the daughter Mary? By the 1880 census of the same county, James has married Mollie Newport and John is living in their household. (In this census James is listed as James W. Kelley but a niece has said very definitely that his name was James Daniel. He named one of his sons J. D.) Again, where was the sister, Mary? By the 1900 census of Pope County, John Kelley is listed as the head of his own household, living with his wife, Mary A. and two children, Ida B. and James W. John Kelley died in August of 1917 or 1918. His daughter, Lucy, relates that the doctor's term for the cause of death was "...brain congestion...". He died on a Sunday. The family was going to a church affair in the afternoon and he told his daughters to go on, that he was not feeling well. When they returned late in the afternoon he was very ill, the Dr. was sent for but he died sometime before midnight.

MARY ALVA RACHEL GENTRY

There is some controversy around this woman's name. She was known everywhere as "Rate" or "Ratie" or "Rettie". To her many nieces and nephews she was "Aunt Rate". Her son, Adell, always said her name was Rachel and this was confirmed by one of her nephews but no document has yet come to light to prove this. A photograph of "Rate" or "Ratie" Gentry, possibly the only one in existence, shows a face almost square and full fleshed, dark hair pulled severely back away from her face, dark eyes and rather high cheekbones. It shows a definite resemblance to a photograph of her mother, Harriet L. (Morgan) Gentry whom, I suspect, was of Welsh descent.

(27)IDA BELLE KELLEY was a small woman with long dark hair that was usually pulled severely away from her face which was small featured. Old photographs show a marked resemblence to her father though the one photograph of John Kelley was taken in his older years there is a like shape to the brow, eyes and nose in both of these people. Ida Belle (always referred to as "Ider") suffered an almost total hearing loss until in her later years, long after her family was raised, she underwent surgery which restored her hearing to near normal ability. She was a quiet, gentle woman, a hard worker, often working in the cotton fields in the fall, and still maintaining her home and raising her family of six daughters.

On 2 November 1918 Ida Belle Kelley married George Washington Bratton, born 15 June 1900 to James Bratton and Rosa Ellen ("El") Stevens. They were married in Russellville, Pope County, Arkansas. This marriage ended many years later in divorce and George Bratton remarried. Ida Belle continued her independent life until she went to live in a care home where, after several years, she passed away 28 March 1988 at age 91.

(28)JAMES WILLIAM KELLEY (aka "Willie", aka "Bill"): Born in the first month of a new decade (18 January 1900) at Dover, Pope County, Arkansas, James William was a small boned, slightly built man. He too bore a marked resemblance to his father, John Kelley. On June 5th 1920 he married Lily Lucille ("Celie") Moore, daughter of Joel Buchanon Moore and Dora Esther Kathryn Lewallen. "Celie" was born on 8 February 1904 at Atkins, Pope County, Arkansas.

James William appears in the 1900 and 1910 censuses of Pope County, Arkansas in the household of his parents. In the 1920 census of Pope County, in the Illinois Township and on the Dardenelle Road, he is listed as the head of household with his sister, Lucy M. and his brother, Clarence A. as the other members of his household. His older sister, Ida B., now Mrs. George Bratton, was living next door.

In the late1920s James and "Celie" moved to Okmulgee County, Oklahoma to the little town of Beggs where he and his brother, Clarence Adell went to work on the farm of a Mr. Wilson. Their fourth child was born there. By 1931, they had moved with their family to Sand Springs, Tulsa County, Oklahoma. They later moved back to Beggs

and remained there for only a short time before returning again to Sand Springs where they continued to live until the early 1940s.

By the middle of this decade (1940s) they had moved to Hanford, Califonia in the San Juaquin Valley where their last two children were born and where their youngest child died and was laid to rest in March of 1950. Shortly after this they moved to San Diego, San Diego County, California where they remained until "Celie" passed away in 1956. James William, after several years, went to live with his daughter, Alene, in Riverside County and remained with that family until his death in 1969.

(29)LUCY MYRTLE KELLEY: Like all of John Kelley's children, Lucy Myrtle was a slightly built woman but she did not display the narrow face and nose of her father. Her face was more rounded, like her mother's, but, with a softer look. Her voice was soft and calm as was her manner, always. She was born 24 January 1902 (or 1903 - records differ) in Dover, Pope County, Arkansas. She married, on 28 July 1920, Christopher Columbus Waits at South New Hope (near Russellville), Pope County, Arkansas. This couple moved from Pope County sometime in the early 1920s and lived for some time in Colorado where the first of their children were born.

They returned to Pope County, Arkansas about 1927 and remained there until they moved to Missouri in the 1930s.

They came to San Diego County, California in 1939 to the little town of El Cajon, about 15 miles east of the city of San Diego. They remained in the vicinity of El Cajon until their deaths. Christopher Columbus died in El Cajon several years before Lucy's death, also in El Cajon, on 31 May 1990. She is buried in San Diego, San Diego County, California in the Greenwood Memorial Park.

Life was hard during her young life, as it was for everyone during those years, and she, like her sister and brothers, often had to work in the fields. The story was often told of taking her first baby to the cotton fields with her and placing the baby on the end of her cotton sack which she pulled along behind her as she picked cotton.

Christopher Columbus worked in the construction trades in California in his later years.

Both he and Lucy and their children attended the Assembly of God Church and were very actively involved.

(30)CLARENCE ADELLBERT KELLEY

Adell, as he was always known, was born 2 October 1905 at Dover, Pope County, Arkansas. Again a small, slightly built man and again with similar features of his father, John Kelley. He married Viola Eugenia Montgomery on 24 December, 1925 in Russellville, Pope County, Arkansas. She was born 1 April, 1908, the daughter of Eugene Montgomery and his third wife, Claribel Ada Parsons. They moved in to her parents home place where her father still lived just outside of Russellville in the Gum Log community. Their first child was born in this house and shortly thereafter this family moved in to a small, rented house in an isolated part of the county "...under the Cagle Rock..." where snakes were abundant. A family story tells how one was found on the porch where the baby had been placed on a quilt upsetting Viola needless to say. In a very short time Adell moved his family to a less primitive neighborhood.

About 1927 or 1928 the family moved to Beggs, Okmulgee County, Oklahoma along with other relatives all looking for work as farm hands. Adell and his brother, James William went to work for a Mr. Wilson. The family later moved to Sand Springs, Tulsa County, Oklahoma where some of Adell's Gentry relatives were living. They remained in that vicinity until 1942 when they moved to San Diego County, California to work in the defense plants for by this time the United States had entered WWII.

Shortly after the end of WWII, the family moved to Missouri and lived there for about one year. Adell and his daughter found work at Ft. Leonard Wood, an Army base which was being closed down, and after a time, the family was assigned housing on the base which ended the long commute of about 70 miles each way from Cabool, Missouri. When the phase out of Ft. Leonard Wood was complete the family (excluding the older daughter who had married) moved again to California. They obtained work in the San Joaquin Valley but lived there only for a short time before returning to the San Diego area. Viola died 24 July 1952 of Bright's Disease and Adell's death occurred almost 30 years later on 8 August 1981. They are both buried in Glen Abby Memorial Park in Chula Vista, San Diego County, California.
